You will be given the choice whether you are happy for the interview to be video recorded. This is optional.

Why am I being invited to take part? You are being invited to participate in this research because you are a parent/carer who has requested an Education Health and Care Needs Assessment (EHCNA) for your child.

**Who is carrying out the research?** I am carrying out the research as part of my doctoral training. I am being supervised by Dr Jo Van Herwegen and Dr Jeremy Monsen.

**Will anyone know that I have been involved?** Your involvement in the research will be kept anonymous. We will give you a different name and not refer to your local authority or school.

What will happen to the results of the research? The research will be written up into a report and submitted as part of my doctoral studies. The report may be considered for publication in an academic journal. You will be asked whether you would like to receive a summary of the data once completed. If you would like to receive this, you will be asked to leave your email address. Once the report has been shared with you, your email address will be permanently deleted.

**Do I have to take part?** It is entirely up to you whether you choose to take part. I hope that if you do choose to be involved then you will find it a positive experience.

**Can I withdraw my response once I have completed the survey?** If you want to withdraw from the survey before submitting your answers, you can do so by closing the browser. After submitting the survey, unless you choose to leave your email address, it will not be possible to withdraw your data as your response will not be identifiable.

**Can I withdraw from the interview?** If you change your mind at any point, you have the right to withdraw from the interview without explanation. If you choose to withdraw your data will be permanently deleted and not included in the research. You can withdraw at any point up until 31<sup>st</sup> March 2024 when the research will have been written up.
